Thank you for submitting your article (the "Contribution") for publication in Oil Palm Industry Economic Journal (OPIEJ). In order to expedite the editing and publishing process and enable Malaysian Palm Oil Board (MPOB) to disseminate your article to the fullest extent, we need to have this Copyright Transfer Agreement executed. If the article is not accepted for publication, or if the article is subsequently rejected, this Agreement shall be null and void.

This is an agreement in which you, the authors (the contributors), assign copyright in your article to MPOB registered in Malaysia, Registered office: No 6, Persiaran Institusi, Bandar Baru Bangi, 43000 Kajang, Selangor, to allow Oil Palm Industry Economic Journal (OPIEJ) hosted by MPOB, to publish your article for the full period of copyright throughout the world, in all forms, all platforms and all media.

Publication Cannot Proceed Without A Signed Copy of This Agreement

A. COPYRIGHT

1. The Contributor hereby grants to Malaysian Palm Oil Board (MPOB) an exclusive, royalty- free, worldwide licence during the full term of copyright and any extensions or renewals, all copyright in and to the Contribution, and all rights therein, including but not limited to the right to publish, republish, transmit, sell, distribute and otherwise use the Contribution in whole or in part in electronic and print editions of the Journal and in derivative works throughout the world, in all languages and in all media of expression now known or later developed, and to license or permit others to do so. For the avoidance of doubt, "Contribution" is defined to only include the article submitted by the Contributor for publication in the Journal and does not extend to any supporting information submitted with or referred to in the Contribution ("Supporting Information"). To the extent that any Supporting Information is submitted to the Journal for online hosting, the Malaysian Palm Oil Board (MPOB) is granted a perpetual, non-exclusive license to host and disseminate this Supporting Information for this purpose.

2. Reproduction, posting, transmission or other distribution or use of the final Contribution in whole or in part in any medium by the Contributor as permitted by this Agreement requires a citation to the Oil Palm Industry Economic Journal (OPIEJ) suitable in form and content as follows:

(Title of Article, Contributor, Journal Title and Volume/Issue, Copyright © [year], copyright owner as specified in the Journal, Publisher). Links to the final article on the publisher's website are encouraged where appropriate.

3. The Contributor and the company/institution agree that any and all copies of the Accepted Version & Final Published Version or any part thereof distributed or posted by them in print or electronic format as permitted herein will include the notice of copyright as stipulated in the Journal and a full citation to the Oil Palm Industry Economic Journal (OPIEJ). Posting article to any preprint platform or archive is not allowed after submission and acceptance in OPIEJ.

4. This agreement shall have no bearing on the moral rights of the contributor in the manuscript, *i.e.* the right to be identified as the author and the right to object to derogatory treatment of the manuscript. Notwithstanding the copyright ownership set out in this clause, the parties agree that third parties shall attribute Oil Palm Industry Economic Journal (OPIEJ) when reproducing or otherwise using the manuscript. This agreement shall be interpreted and construed according to, and governed by the Malaysian law(s), as applicable, excluding any such laws that might direct the application of the laws of another jurisdiction.

B. RETAINED RIGHTS

Notwithstanding the above, the Contributor or, if applicable, the Contributor's employer, retains all proprietary rights other than copyright, such as patent rights, in any process, procedure or article of manufacture described in the Contribution.

C. CONTRIBUTIONS OWNED BY THE EMPLOYER

If the Contribution was written by the Contributor in the course of the Contributor's employment (as a "work-made-for-hire" in the course of employment), the Contribution is owned by the company/institution which must execute this Agreement (in addition to the Contributor's signature). In such case, the company/institution hereby assigns to the Malaysian Palm Oil Board (MPOB), during the full term of copyright, all copyright in and to the Contribution for the full term of copyright throughout the world.

D. CONTRIBUTOR'S REPRESENTATIONS

The Contributor represents that: (i) the Contribution is the Contributor's original work, all individuals identified as Contributors actually contributed to the Contribution, and all individuals who contributed are included; (ii) if the Contribution was prepared jointly, the Contributor has informed the co-Contributors of the terms of this Agreement and has obtained their signed written permission to execute this Agreement on their behalf; (iii) the Contribution is submitted only to Oil Palm Industry Economic Journal (OPIEJ) and has not been published before, has not been included in another manuscript, and is not currently under consideration or accepted for publication elsewhere; (iv) if excerpts from copyrighted works owned by third parties are included, the Contributor shall obtain written permission from the copyright owners for all uses as set forth in the standard permissions form; (v) the Contribution and any submitted Supporting Information contains no libelous or unlawful statements, does not infringe upon the rights (including without limitation the copyright, patent or trademark rights) or the privacy of others, or contain material or instructions that might cause harm or injury and only utilize data that has been obtained in accordance with applicable legal requirements

and Journal policies; (vi) there are no conflicts of interest relating to the Contribution, except as disclosed. Oil Palm Industry Economic Journal (OPIEJ) reserves the right, notwithstanding acceptance, to require changes to the Contribution, including changes to the length of the Contribution, and the right not to publish the Contribution if for any reason such publication would in the reasonable judgment of Oil Palm Industry Economic Journal (OPIEJ) result in legal liability or violation of journal ethical practices.
